## **U.S. Department of Education Releases Race to the Top State Progress Reports**

On March 19th, the year three Race to the Top state progress reports for the District of Columbia and the 11 states that received grants in the first two rounds of the program: Delaware, the District of Columbia, Florida, Georgia, Hawaii, Maryland, Massachusetts, New York, North Carolina, Ohio, Rhode Island and Tennessee were released by the U.S. Department of Education. They reflect reporting done for the school year of 2012/2013. The reports show the progress that each state has made against their original plan they set forth at the beginning of the program.

As Acting Assistant Secretary for Special Education and Rehabilitative Services, Yudin serves as the Secretary of Education's principal adviser on special education, vocational rehabilitation, and disability and rehabilitation research.

# U.S. Department of Ed Prioritizes Students with Disabilities in New Investing in Innovation Grant Competition

The U.S. Department of Education announced the start of the \$134 million 2014 Investing in Innovation (i3) grant competition for pre-applications for the i3 "Development" grants (up to \$3,000,000 each), which funds grantees with promising but relatively untested ideas. This year's priorities for the Development grant category are: Improving Academic Outcomes for Students with Disabilities, Effective Use of Technology, Improving Academic Outcomes for English Learners (ELs), Improving the Effectiveness of Teachers or Principals, Improving Low-Performing Schools, and Serving Rural Communities.

H.R. 3683 - 'To amend the Elementary and Secondary Education Act of 1965 to establish the Teacher Incentive Fund Program, and for other purposes.'

H.R. 3578 - 'To amend part B of the Individuals with Disabilities Education Act to provide full Federal funding of such part.'

H.R. 2597 - 'To amend the Elementary and Secondary Education Act of 1965 to allow State educational agencies, local educational agencies, and schools to increase implementation of school-wide positive behavior supports.'
